Mayor Lenseigne opened the Regular Council Meeting at 7:00PM.

**1. APPROVE MINUTES FROM JUNE 09, 2022, CITY COUNCIL MEETING.**

Mayor Lenseigne asked if there were any corrections, additions, or omissions to the minutes of June 9, 2022. There were none.

**ACTION NO. 1** Council member Layman made a motion to accept the minutes as prepared.  
Council member Frank seconded the motion. The motion carried.

**2. PROGRESS PAYMENT #8 TO SELLAND CONSTRUCTION, INC. FOR THE WORK PERFORMED ON THE MORRIER LANE EXTENSION PROJECT THROUGH JUNE 25, 2022**

Mayor Lenseigne read a letter from HLA regarding the recommendation to make progress payment #8 to Selland Construction in the amount of \$5,562.43 for work performed through June 25, 2022.

**ACTION NO. 2** Council member Spurgin made a motion to authorize progress payment #8 to Selland Construction, Inc. for the work performed through June 25, 2022, on the Morrier Lane Extension Project in the amount of \$5,562.43.  
Council member Hutchinson seconded the motion. The motion carried.

**3. ORDINANCE #816 AN ORDINANCE GRANTING A FRANCHISE TO CASCADE NATURAL GAS CORPORATION TO CONNECT, INSTALL, AND MAINTAIN A NATURAL GAS DISTRIBUTION SYSTEM.**

City Clerk-Treasurer Conger stated that there was little change to the agreement. City Supervisor Burkett had been working with former City Supervisor Adams prior to Adams retirement on this. He had also spoken to the City's attorney who did not see any problems with it.

**ACTION NO. 3** Council member Frank made a motion to dispense with the reading of Ordinance #816.  
Council member Layman seconded the motion. The motion carried.

Mayor Lenseigne discussed a letter that was sent into the City's website email. The letter stated it was a complaint about the Fourth of July celebration that seems to get worse every year with chaotic and unsafe fireworks. Mayor Lenseigne expressed his concern with roads being hard to navigate from people setting off fireworks in the streets. Fire Chief Hille said there were only 4 calls, but that fireworks were shot at a fire truck responding to a dumpster fire call. Council Member Layman suggested possibly requiring firework permits in the future.

Police Lieutenant Lewis reported normal calls since last report. Lewis also reported on July 11<sup>th</sup> there was a call at the Super 7 regarding an 80yr old woman who had lost her wallet, was out of gas, and was needing to get home. Officer Reese, using his own money, filled up her gas tank. They followed up. She had made it home safely.


